APPLICATION GUIDELINES

SUMMER CAMP SCHOLARSHIPS

The summer camp scholarships are awarded to children with special needs to give them an opportunity to continue their learning through recreational experience. **Average grant amounts are up to \$200.00.**

ELIGIBILITY

The Foundation invites Montgomery County **public school** parents of school-age students with special needs to apply. **Eligible applicants are children (K-12) with special needs with an active special education individualized educational plan (IEP) and the children must be eligible for “free or reduced price meals” from the resident school district.**

REQUIREMENTS CHECK LIST

- Student Information
- Parent Information and Signature
- Camp Information (name, address, telephone number and camp contact person)
- School Information to include letter of recommendation from a student’s teacher
- Signature school Principal to verify current IEP and eligibility of free or reduced lunch

TIMELINES

Completed applications are to be forwarded by parent(s) to the child’s school building principal for verification of eligibility. **Following verification, the school representative will forward the original authorized application to the Foundation by the close of business (4:00 p.m.) on March 23, 2018. Applications received after this date will not be considered. There will be no extensions. Incomplete applications will not be considered.**

NOTE: *Payment to camps will only be made after a copy of the camp registration and/or invoice is sent to the MCIUEF (ksmith@mciu.org) verifying enrollment/registration in the camp.*

DISCLAIMER

Due to the fact that many camps in this area will decide on enrollment deadlines over a two to three month period of time, the Foundation will do its best to keep to the timelines as stated above. The Foundation **will not be responsible** for any deposits/payments/fees made for any student at any camp/institution prior to notification that a grant award has been made.
